Some Questions To Consider

- Why should elected officials/staff/agency officials care about your institution & what you want?
- What do you want out of the political and policy process?
- How is your institution perceived in your community? State?
 Nationally?
- Who are the ambassadors of your institution? (touch points)
- What assets do you have to get what you want out of the political process?
- What relationships do you have that can help with your advocacy?



What do I Advocate For?

- Legislative wins & defeats
- Bill proposals
- Letters of support
- Proclamations
- Federal appropriations requests
- Grant awards
- Agency and legislative solutions to institutional problems
- Institutional visibility
- Access
- Participation and support for institutional events and initiatives



Identify & Recruit Your Coalition Partners

- What associations are you a member of? (Institutional & Individual)
- What value are you getting out of those memberships?
- Which associations will get you to where you want to go?
- Strengthen relationships and familiarity between your associations and your institution
- Support your associations when they need your help



The Art of Scheduling a Government Meeting

- Know who to meet with & when
- 5-10 minutes max
- One pagers, not packets!
- Identify your asks
- Connect staff with your staff
- Connect electeds with your leadership
- Reach out & schedule meetings regularly
 & often



Establish Credibility & Influence

- Use facts & institutional data to tell your story
- Understand what politicians want & react to
- Be relevant & knowledgeable
- Let your third-party validators speak for you
- Use existing relationships to open doors
- Use your prestige and assets!





Build Your Advocacy Toolbox



- Hire a Director of Government Relations, and/or State or Federal Lobbyist
- Political & Policy Intelligence (State & Federal)
 - Have the information you need to advise internal decision makers on legal, political and legislative action which may impact your institution, students & competitors
 - POLITICO Pro, CQ Roll Call, Capitol Morning Report
- Legislative Monitoring
 - Manage a bill matrix
 - CapitolTrack, TrackBill



Strengthen Relationships & Institutional Visibility

- Bring your institution to Capitol Hill!
- Campus tour & briefing for elected officials
- Legislative summit for staffers
- Continued passive information: E-newsletters
- Win-win scenarios
- Be opportunistic
