Intern Duties: Analysis pension databases containing approximately 500,000 records and building charts and/or graphs to show trends in the data. Analysis also includes studies of costs incurred by pension plans that could result in either model practices or identification of high cost plans. Other assignments could include review of pension plan financial statements, analysis of cash flow statements and testing of benefit calculations using Microsoft Excel.

To include meeting coordination such as scheduling meetings, compiling materials for these meetings, including presentations, making sure participants get the materials before the meeting, preparing meetings agendas, taking minutes and compiling meeting minutes including agreed upon next steps and action items. Other duties: assisting with the OBA Audit Quality Standards Exposure draft comment and disposition process and creating, updating and maintaining the comments disposition tracker spreadsheet. The intern will update and maintain agency websites with recommendation closure form materials.

Posted by the National Credit Union Administration: Preferred Skills: detailed orientated, has solid writing skills, interest in accounting or auditing. The intern will get exposure to accounting operations at a federal entity, and have the opportunity to do a variety of tasks, such as: Conduct expense report audits to ensure that reimbursements are made in accordance with agency policy; Issue Statements of Difference to employees; Monitor and manage the resolution of overand underpayments; Conduct compliance audits on relocation expense reports to ensure that reimbursement are made in accordance with agency policy; Update relocation schedules and perform relocation general ledger to subsidiary ledger reconciliations.

Posted by the Pension Benefit Guaranty Corporation: Assisting the IAB Accountants in their day-to-day work, which includes: Creating balance sheets for defined benefit pension plans that have been terminated by PBGC; Preparing various Excel spreadsheets with built-in formulas that calculate realized gains and losses on investments held by terminated pension plans; Analyzing bank statements for pension plans, determining the proper accounting treatment for various transactions, and preparing journal entries that properly reflect the financial activity of the plan; Posting those journal entries to the general ledger; Utilizing pricing services to determine the value of investments as of the Date of Plan Termination for terminated pension plans; Preparing journal entries to "clean up" balances on old plans; Preparing various ad hoc reports as requested by IAB management; Analyzing ledger account balances to ensure the asset and contra asset accounts are properly reflected in the ledger
